The Nominating Committee shall consist of seven (7) members to be chosen as follows: four (4) members will be elected at the Annual Meeting of the Cathedral from among candidates nominated by the Vestry and any candidates nominated pursuant to Section 2 of this Article V. Pursuant to proposed amendments to the Code of Regulations, the members of the Nominating Committee who are elected will generally serve a term of two years. During the initial period of this change to the Regulations, certain of those persons elected shall be designated to serve a term of one year, while certain others will serve the standard term of two years in order that terms will be staggered on a going forward basis.
